State funding for civil legal aid is appropriated through the Illinois Equal Justice Act and housed in the Attorney General's budget. The Act, approved by the General Assembly and signed into law in 1999, recognizes the State's responsibility to ensure equal access to the legal system. It sets forth a wide range of innovative, cost-effective initiatives to help low-income people understand the legal system and resolve their routine legal problems more effectively. The Act also created the Illinois Equal Justice Foundation to distribute the State's appropriation for civil legal aid to not-for-profit organizations throughout the state.

In December 2014, the IEJF awarded over \$1.3 million in grants to 13 not-for-profit organizations to provide civil legal assistance to families and seniors in legal crisis. Since its inception, IEJF grant funds have increased access to the civil justice system for over 520,000 Illinoisans.
